090125/9 COUNTY AND DISTRICT COUNCILLOR REPORTS

AS provided updates were provided on the timeline of the various local authorities for the 'unitarisation' of a number of England's two-tier counties as part of its forthcoming devolution white paper. Unitarisation involves the replacement of separate county and district councils with a single tier of local authorities. County Councils are responsible for functions such as transport, social care and education. District Councils are responsible for matters including housing, planning and waste collection. Unitary authorities are responsible for all these functions within their area. Fortunately, Unitarisation does not affect Parish Councils and Town Councils, the lowest tier of government in England.

JL provided an update on the effectiveness and availability of Defibs and competent personnel to use such in emergencies and compared to Sweden (with a success rate of some 50% survival rate), the UK is typically 10%. It was announced that more Defib training in conjunction with the Air Ambulance would be available within the village and that personnel wishing so, could be kept on a database available on an App so as to be contacted in an emergency.
