District Council Reorganisation discussions are on-going.

Highways has outlined a draft capital works schedule that included resurfacing of Station from in the 2025-26 year. AS to provide a full breakdown for council.

#### 130325/10 ENVIRONMENT AND FOOTPATHS

JM updated council that since last meeting, Footpath map leaflets been placed at The Boot and Ellesmere Centre, Parish noticeboard and on the village Facebook group. One given to a resident, who requested one and some given to Scouts Leader,

JM had made contact with the County Byway Officer and the following had been discussed: CCC will replace the broken post on FP1 (just past cattle arch coming from the village). CCC will supply a definitive footpath for Dullingham. The matter of a dedicated footpath board was ongoing.

Watery Lane – flooding & surface poor, CCC has contractors lined up to resurface and improve stream banks this summer

Pathway 3 next to the school – CCC is chasing the neighbouring stud to cut back the hedge. May be too late in the year now so may now be early autumn.

RA mentioned an overgrown hedge on footpath 18 that will be looked at before the next meeting.

Ditch/stream at sewage treatment works looks much better, although pipes under bridge near cattle arch are almost entirely blocked by tree debris. SP/RA to establish a contact at Stetchworth Estates.
