#### 100725/6 MATTERS ARISING:

Request for support from Dullingham PCC
 John Dalton had written to the Parish Council in advance of the meeting requesting support.

I am writing on behalf of St Mary's Parochial Church Council (PCC) to raise two matters which we very much hope you can assist us with. Request for Funds The PCC is responsible for funding all operational costs of the church, such as utilities, maintenance and insurance, and together with the other five parishes in the benefice, the salary of the incumbent rector. We receive no funds from the Church of England to cover or underwrite any of these costs. Furthermore, we have to raise funds to cover repair and refurbishment of the Grade I listed building: the amount we need to raise currently stands at approximately £100k. Again, we cannot request funds from the Church of England to cover or contribute to these costs. We raise funds principally through our services, regular giving by members of the parish, and through fundraising events such as the village fete (see below). Funds raised from these various sources just about cover our operational costs, with small sums set aside for unexpected maintenance bills, and a small reserve we are accumulating as a required contribution to any grants we are fortunate to receive to undertake capital works. Grants are extremely competitive, but are the main route by which we can seek capital funds, and our strategy is to pursue this

avenue to finance our most urgent repair needs for the interior of the church. Turning to the matter-at-hand, we are seeking funds from the Parish Council to cover: 1. replacement of the path that runs through the churchyard and 2. Refurbishment of the tower clock face. The path is used by many villagers: dog walkers, as a cut-through between Church Lane and Church Close, to connect to the public footpath to the east of the church, to visit loved ones who are buried or remembered in the churchyard, or simply to enjoy the peaceful environment. The path is, however, in a terrible state, potentially dangerous underfoot and urgently in need of replacing. Quotes for this work range from £7,000 to £10,500. On many evenings the chimes from the church clock can be heard throughout the village. Through the generosity of a member of the parish, we have recently part repaired and refurbished the clock's mechanism, but the strike hammer needs repairing and the clock face is horribly weathered, and is in need of restoration. It would be wonderful if the clock can be fully reinstated to its former glory and enjoyed visibly and audibly by villagers for many years to come. The cost of these works is £10,230. We very much hope the parish Council will be minded to contribute to these costs, recognising the value that the external environment of the church brings to village life, and would allow us to focus on raising funds for the many repairs needed to the interior of the church. Organising the Village Fete The annual village fete has been a staple of village life for many years, enjoyed by many, and it is our main fundraising event. Over the past few years, however, it has become increasingly clear that as a small and ageing congregation we cannot continue to organise the fete without external help. Each year we put out a call for volunteers and helpers, and indeed a handful of villagers do sometimes assist on the day, but the current model is unsustainable and for the village fete to continue beyond this year, it needs to be put on a more robust footing. We are therefore seeking partnership with the Parish Council on a profit and risk sharing basis, working together to organise and host the fete, and thus continue this intrinsic aspect of village life. We thank you for your time to consider our requests, and would be happy to provide additional information and discuss further. If it is at all helpful, we can also attend a meeting of the Parish Council or Parish Council representatives. Having discussed at length in an open forum it was agreed that the Parish Council fully support the PCC in helping to find a solution to keep the beautiful church in Dullingham thriving for years to come and as a result they will:

They would write directly to the diocese to express their concerns on the current guidelines the PCC are managed under and ask for them to assist further. (the draft letter will be forwarded to the PCC for proof reading).

This letter will openly be shared with the community alongside the PCC's public announcement, which again the Parish Council are happy to provide a platform for this to be shared on the Parish website or help share this on the village Facebook page should assistance be needed. \*\*\*If the announcement requires printing the Parish Council advised they would find the printing costs to assist and help in delivering \*\*\*

The Parish Council hope the communication to be shared will be the catalyst needed and the revival of the Church, its congregation and hopefully some further Church Council members will be found. Dullingham is a wonderful community and the Parish Council know they can come together as they have done so many times before.

The Parish Council would like to revisit the subject in October, which is also budget and Precept season and if you would kindly ask a PCC Representative attend this meeting to update the Parish Council, we can potentially look at Precept a small annual contribution to the Church as a long term contribution.

In addition the Parish Council also **RESOLVED** to donate all Village Green parking fees to the PCC going forward. This is only a small sum of £25 but every little helps.
